NORTH Plan A - Premier Tent Boarding from November 24, 2026 - April 25, 2027 @ \$5,850 per stall. Tent A or Tents 1-8 locations.

SOUTH Plan A - Premier Tent Boarding from November 24, 2026 - April 25, 2027 @ \$5,650 per stall. Tents 9-16 locations.

Plan A includes the Holiday Circuit, WEF and Spring 1-3. This is priced for 22 weeks of stalls @ \$261 per week for North Plan A or \$257 per week for South Plan A. *Reservations and payments received after November 16th, 2026 (if extended) are subject to an increase.*

NORTH Plan B - Premier Tent Boarding from December 28, 2026 – April 4, 2027 @ \$4,400 per stall. Tent A or Tents 1-8 locations.

2026 - 2027 Equestrian Sport Productions Boarding Rules

*PLEASE NOTE: FOR ALL BOARDERS SAFETY, NO ADDITIONAL COVERAGE MAY BE CONSTRUCTED OUTSIDE OF ANY STABLING STRUCTURE WITHOUT THE **WRITTEN** PERMISSION OF MANAGEMENT. YOU WILL BE CHARGED FOR ANY VIOLATION AND/OR DAMAGES! NO EXCEPTIONS!*

GENERAL STABLING RULES

1. For continued equine safety, all horses are subject to WEF 2027 Wellington International biosecurity protocols and current NW Screw Worm requirements before stabling or showing at the facility. Everyone will be required to sign a waiver and acknowledge these protocols before being allowed on the property. No exceptions.
2. No horse transport vehicles of any kind will be allowed on the property Wednesday – Sunday between the hours of 6:30 am and 8:30am.
- 3. NO PAINTING STALLS OR ATTACHING ANY OBJECTS OUTSIDE OF STALLS WITHOUT OBTAINING PRIOR WRITTEN PERMISSION FROM MANAGEMENT. CHARGES FOR REPLACING PAINTED WOOD, DAMAGES, OR REMOVING ATTACHMENT WILL BE APPLIED.**
4. NO ONE MAY USE ANY ELECTRICAL OUTLET TO CONNECT ANY CORD, OR APPLIANCE THAT IS DEEMED DEFECTIVE OR DOES NOT MEET LOCAL CODE AND ANY SUCH ITEM MAY BE REMOVED WITHOUT CLAIM FOR DAMAGES. PLEASE READ POSTED NOTICES OF NEW FIRE MARSHALL REGULATIONS
5. ELECTRIC OUTLETS ARE FOR FANS, CLIPPERS, SMALL RADIOS, AND OTHER APPROVED SMALL APPLIANCES. NO GOLF CARTS, HEATERS OR LARGE APPLIANCES MAY BE CONNECTED TO THESE OUTLETS. ESP LLC MAY REMOVE UNAUTHORIZED APPLIANCES OR REFUSE USE OF OUTLETS AS IT DEEMS REASONABLE.
6. GOLF CARTS MAY BE DRIVEN ONLY BY LICENSED DRIVERS. IF ESP ISSUES ID PASSES TO GOLF CARTS OR OTHER CONVEYANCES ONLY PROPERLY PERMITTED CONVEYANCES WILL BE ALLOWED.
7. OFF SITE VAN & TRAILER PARKING (IF AVAILABLE) IS BY PERMIT AND PERMIT NUMBER ONLY MUST BE DISPLAYED ON VEHICLE AT ALL TIMES.
8. ALL VEHICLES MUST BE DRIVEN AT SLOW, SAFE SPEEDS AND FOLLOWING ONE WAY TRAFFIC AS POSTED. CAUTION OF HORSES AND RIDERS MUST BE TAKEN AT ALL TIMES. UNSAFE DRIVING WILL NOT BE TOLERATED AND MAY LEAD TO EXPULSION WITHOUT REFUNDS.
9. LUNGING MAY BE DONE ONLY IN THE DESIGNATED AREAS. NO LUNGING MAY BE DONE IN ANY OF THE RINGS OR SCHOOLING AREAS AT ANY TIME UNLESS OTHERWISE POSTED.
10. PADDOCKS MAY NOT BE ALTERED AT ANYTIME WITHOUT EXPRESS PERMISSION, AND MAY ONLY BE USED BY THOSE INDICATED ON THE USE AGREEMENT. DAMAGE TO PADDOCKS WILL BE THE EXPENSE OF THE USER, NO LUNGING IN PADDOCKS.
11. PRACTICE RINGS AND PRIVATE RINGS (if available) ARE TO BE USED IN A SAFE & COURTEOUS MANNER AND ONLY BY PERSONS AND OR HORSES WITH PROPERLY SIGNED ENTRY BLANKS AND DISPLAYED BACK NUMBERS. JUMPS THAT ARE DEEMED TO BE UNSAFE MAY BE REMOVED WITHOUT CLAIM. NO POLING AT ANY TIME.
12. BMP- MANURE AND WASTE MUST BE PLACED IN THE DESIGNATED CONTAINER AREAS ONLY. HORSES MAY ONLY BE WASHED IN PERMANENT WASH AREAS PROVIDED BY ESP. FINES FOR NONCOMPLIANCE MAY BE APPLIED. MANAGEMENT RESERVES THE RIGHT TO MODIFY ANY BARN REGULATIONS FOR GOVERNMENT REGULATIONS AND/OR HORSE OR HUMAN WELFARE.
13. ALL USE AREAS MUST BE KEPT CLEAN AND NEAT AT ALL TIMES.
14. ALL AREAS ON THE PROPERTY MUST BE USED PROPERLY AND FOR THE INTENDED PURPOSE ONLY. THIS INCLUDES STALLS WHICH MAY ONLY BE USED FOR HORSES, TACK STALLS OR FEED STALLS. NO BUSINESSES MAY BE RUN IN A RENTED STALL.
15. PARKING AREAS FOR CARTS, BIKES AND VEHICLES MUST BE PROPERLY OBSERVED AND ANY RESERVED AREA MUST BE USED ONLY BY THE PROPER PERSON(S).
16. PETS MUST BE KEPT ON A LEASH (OR CAGED) AT ALL TIMES AND MAY NOT GO INTO THE RINGS OR SCHOOLING AREAS AT ANY TIME. VIOLATIONS SUBJECT TO FINE. ANY PET THAT DEMONSTRATES AGGRESSIVE BEHAVIOR MAY BE BANNED FROM THE PROPERTY AT MANagements SOLE DISGRESSION.
17. DELIVERIES: ALL DELIVERIES (IF ALLOWED) MUST BE CLEARED FIRST BY THE OFFICE AS TO TIMES AND PLACEMENT. ONLY GOLD COAST FEED IS PERMITTED TO DELIVER FEED, BED AND SHAVINGS ON THE GROUNDS.
18. NO STALL, PADDOCK, RING, PARKING SPACE, OR OTHER USE AREA MAY BE USED UNTIL A USE AGREEMENT IS PROPERLY SIGNED AND UNTIL PAYMENT IS MADE.
19. ANY UNPAID BALANCE OR NON-NEGOTIABLE FEES FOR RENTALS MAY RESULT IN AN INCREASE IN THE FEE OF \$100 PER WEEK AND WILL TERMINATE THE USE IMMEDIATELY UNTIL THE FEE IS PAID WITH CERTIFIED FUNDS. ALL FUNDS ARE U. S. FUNDS ONLY. ALL STABLING FEES ARE NON-REFUNDABLE.
20. USER IS RESPONSIBLE FOR ANY DAMAGE TO FACILITY. NO PAINTING, CUTTING, OR ALTERING OF THE STALLS WILL BE PERMITTED.
21. PLEASE NOTE: FOR ALL BOARDERS SAFETY, NO ADDITIONAL COVERAGE MAY BE CONSTRUCTED OUTSIDE OF ANY STABLING STRUCTURE WITHOUT **WRITTEN** PERMISSION FROM MANAGEMENT. NO ITEMS MAY BE PLACED OR STORED OUTSIDE OF THE STABLING TENT THAT MAY BLOCK FIRE TRUCK/ EMERGENCY VEHICLE ACCESS. THIS INCLUDES BUT NOT LIMITED TO: HAY, SHAVINGS, DOG PENS, WASH RACKS, ETC. THERE WILL BE NO EXCEPTIONS!
22. NO STALL AND/OR USE MAY BE TRANSFERRED TO ANY THIRD PARTY WITHOUT THE EXPRESS CONSENT OF MANAGEMENT.
23. NO MONITORING CAMERAS MAY BE CONNECTED TO ESP NETWORKS OR WI-FI WITHOUT USE FEES BEING PAID IN ADVANCE AND PERMISSION BY MANAGEMENT.
24. NO NUISANCE OF ANY KIND WILL BE ALLOWED. INCLUDES NOISE, PARTIES, FIGHTING, HORNS, LOUD ENGINES, BARKING-BITING DOGS, DRUNKEN BEHAVIOR, ETC.
25. USER AGREES TO HOLD ESP, LLC HARMLESS OF ANY AND ALL CLAIMS.
26. A PROPERLY FITTED ASTM HARD HAT MUST BE WORN BY ANY PERSON ON A HORSE AT ALL TIMES ON THE SHOW GROUNDS.
27. A 3.5% ADMIN FEE WILL APPLY TO PAYMENTS NOT MADE BY VALID CHECK OR WIRE TRANSFER.
28. FAILURE BY ANY PERSON TO FOLLOW THESE RULES AND REGULATIONS MAY RESULT IN THE LOSS OF THE USE AREA AND THE REMOVAL OF ALL ANIMALS, TRAILERS, VEHICLES, SUPPLIES ETC. RELATING TO SAID PERSON WITHOUT REFUND OR CLAIM FOR DAMAGES.
